In alignment with our vision to share & deepen *NVC* consciousness with as many people as possible within a diverse community, we are making a **special offer** to participants who have authentic financial limitations. If you are committed to deepening your *NVC* practice, and imagine sharing your *NVC* consciousness with others in the future, we are eager for you to participate. Our goal is to have as much diversity as possible within our community. Each year we are heartened by the depth of connection that arises across boundaries not usually crossed in our day-to-day lives.

Scholarships are NOT full payments.

Scholarship awards will range from **10% to 75%** of full cost.

(Full cost = Residential: \$2,900; Commuter: \$2,650)

(Please consider carefully when choosing residential vs. commuter.

There will be an additional cost to change this choice.)

Completed scholarship applications must be RECEIVED by June 20, 2019.

After careful review, we will notify scholarship recipients by **July 1.**

Recipients then have until **July 14th** to accept their scholarship offer
by **submitting their deposit of 20% of their reduced total amount.**

Any offers not accepted by July 14th will be offered to a second round of recipients on July 15th.

November 15: 20%
